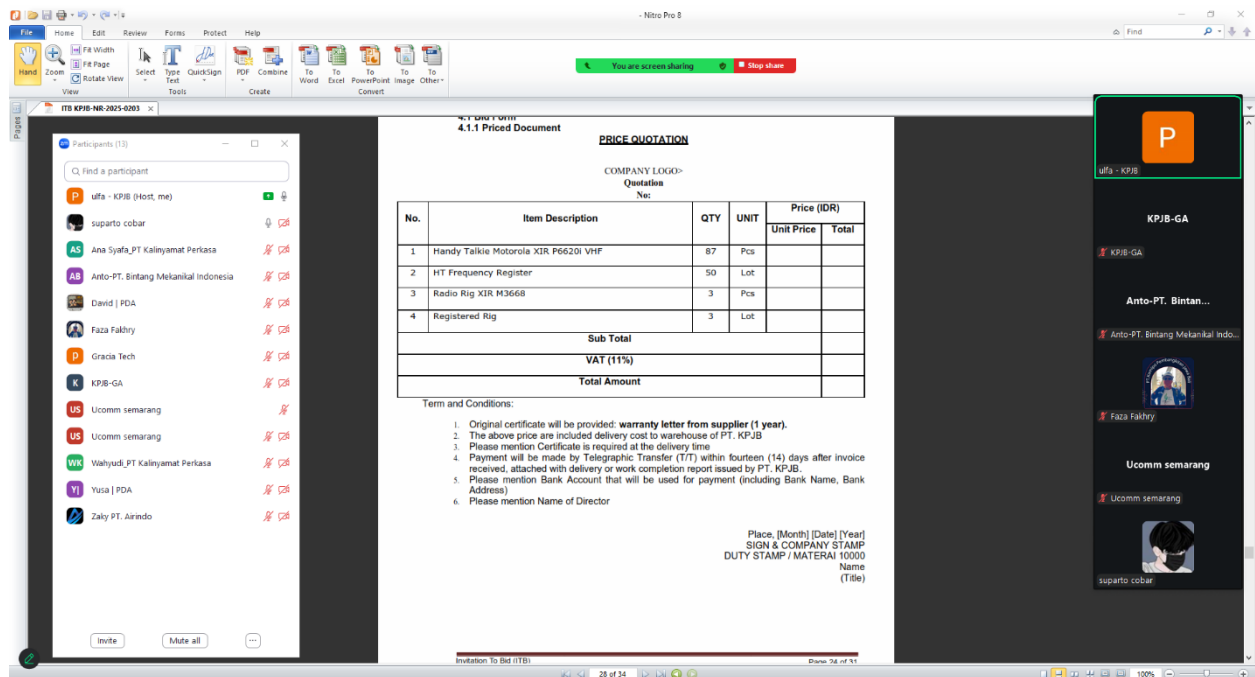

1. Background

Handy Talkie(HT) Radio as one of the vital facilities for communication in supporting of Operation and Maintenance works in Power Plant of Tanjung Jati B unit 3 and 4. The existing radio frequencies and Handy Talkies Radio units used by our staffs are given by the previous contractor that legally managed by them and KPJB has illegal radio frequencies. Refer to unit 1 and 2, currently inspected by Diskominfo found the illegal frequencies for their HTs and subjected to penalty. Currently they registered legal radio frequencies by using 11 radio frequencies for their HTs. KPJB will propose gradually for registering radio frequencies. In 2025 will registered of 3 radio frequencies and gradually will be increased annually based on the need.

The incident of nearmiss in Water Box Unit 3A, the result of the investigation that the instruction through HT radio is not clear that makes miscommunication in execution the instruction. It was a fatal execution due to miscommunication. Legal frequencies is also to avoid double usage with other users when the frequencies number has been owned legally by other parties such as our current radio frequencies owned legally by previous EPCs..

General Affair, HSE and Operation divisions initiated to do trial of frequencies test with several HT types in all areas including radio frequency testing into basement floor. The result of the test shows that in the ground floor and basement floor using analog frequencies, the communication is interrupted and not clear but using digital frequencies is more clear. And the conclusion of the test shows that the most recommendation is using digital HTs and frequencies is more clear receiving and sending voice communication compared with other type such as analog HTs that currently used by KPJBs. JnM divisions is currently already upgraded into Digital HTs.

The upgrading HTs is expected completed before outage 2025 for supporting Maintenance of Outage 2025. This 3 radio frequencies will be allocated into J n M ,Operation and Maintenance divisions that is the priority using.

The current HTs are not monitored well by each divisions since all division decided to procure HTs by each division decision . The replacement and repaired are not managed well where the recorded is not registered including the frequencies used by each division. In the future all assets will be monitored register and managed by GA F and A division not limited for the replacement and repair.

2. Purpose

The purpose of this decision making are.

1. To upgrade the current HTs is to procure new ones and additional RIG.
2. To registered HTs with legal frequencies to the authorised goverment body.
3. To appoint HSE for monitoring the legal frequencies and monthly payment.
4. To appoint GA for register the asset of HTs and monitoring for replacement and repair.
5. To avoid using illegal frequencies since the current frequencies used were illegal.
6. To anticipate repeton of miscommunication during OH 2025 due to HTs and radio frequencies issues. (nearmiss insident)
7. Procurement method will executed by *open bidding or directly to open market store who has offline shop* to make sure warranty claim.
